# A DATA-LED APPROACH

### DRAX was introduced to Lucion Group through Palatine Private Equity to conduct a CFO search.

The objective of the search was to find a CFO who could support the continued growth and development of Lucion Group, and ultimately support the management team and investors to prepare for an exit.

PACE, our bespoke private equity behavioural evaluation tool was used by all shortlisted candidates during the search process to establish the required complementarity with the incumbent team. The data from PACE provided an objective view on behavioural traits, to support the hiring process and ensure a strong fit with the incumbent leadership team.

Speaking on his experience with PACE, Phil Rozier, CEO of Lucion Group said

"It is always useful to get a fresh pair of eyes on PACE test results, because sometimes if you just get presented with the data, you don't really know how to interpret it."

Following a nationwide search, DRAX introduced and supported the appointment of Jo Seymour as CFO. 


